## ACCEPTANCE OF TERMS OF CONDUCT AND RELEASE

I \_\_\_\_\_, acknowledge that as a condition of becoming a new member or renewing my existing membership in the Pharr Rifle and Pistol Club ["PRPC"], that I must agree to certain terms, on behalf of myself and any guests or visitors that I bring onto Pharr Rifle & Pistol Club property. Therefore, I agree as follows on behalf of myself and any guests or visitors that I bring onto Pharr Rifle & Pistol Club property:

**a.** Being on a shooting range is an inherently dangerous activity and I assume the risks of injury to myself, my guests and visitors resulting from my or their presence on PRPC property;

**b.** I release PRPC from any liability to me, and indemnify it for any liability and defense costs it may incur or suffer due to injuries to, or actions and/or omissions by, me or to any guests or visitors I bring onto PRPC property, on PRPC property, DUE TO ANY DANGEROUS THE CONDITION OF THE PREMISES, AND/OR DUE TO ANY FAILURE TO ENACT OR ENFORCE ANY RULES (Safety Rules or other types of rules).

**c.** To comply with ALL current Rules of PRPC and safety standards and regulations, as well as the directives of those designated by PRPC to enforce its rules, standards, and regulations and to oversee safety on PRPC property.

**d.** To be responsible for obtaining and becoming familiar with all current Rules, safety standards, and regulations of PRPC, whether those are provided to me by PRPC or not.

**e.** To be responsible, legally, financially, and otherwise, for all acts and/or omissions of myself and/or the guests and visitors that I bring onto PRPC property, that cause injury or expense to others or to PRPC.

**f.** That any individual or member may be suspended or expelled for good cause, including but not limited to any conduct which is contrary to, in or violation of the Bylaws or safety rules of the association. Members who have had their key seized must attend the next scheduled Club business meeting to present their case. An open ballot of voting members present will decide final action. Arrangements must be made in advance in case of scheduling conflicts.
