a. Being on a shooting range is an inherently dangerous activity and I assume the risks of injury to myself, my guests and visitors resulting from my or their presence on PRPC, Inc. property.

b. I release PRPC, Inc. from any liability to me, and indemnify it for any liability and defense costs it may incur or suffer due to injuries to, or actions and/or omissions by me or to any guests or visitors I bring onto PRPC, Inc. property, DUE TO ANY DANGEROUS CONDITIONS ON THE PREMISES, AND/OR DUE TO ANY FAILURE TO ENACT OR ENFORCE ANY RULES (Safety Rules or other types of rules.)

c. To comply with ALL current Rules of PRPC, Inc. and safety standards and regulations, as well as the directives of those designated by to enforce its rules, standards, and regulations and to oversee safety on property.

d. To be responsible for obtaining and becoming familiar with all current Rules, safety standards, and regulations of PRPC, Inc., whether those are provided to me by PRPC, Inc. or not.
